With reference to above mentioned subject.

2. After going through the recommendations offered by District Education Officer (S.E.) and Director Education Department (S.E.), Punjab, Chandigarh alongwith the documents and affidavit submitted by the school management, the required No Objection Certificate by the Punjab Govt. is issued on the following conditions: -

1. In future during any complaint/inspection, if the facts come out that you submitted application on the basis of wrong information to the govt. to obtain No Objection Certificate and or you do not comply with the instructions issued by the govt. from time to time and written conditions mentioned in your affidavits are not being followed then in that eventuality this No Objection Certificate would be withdrawn at any time.

2. It will be compulsory to teach Punjabi Language upto 10th Standard in your school and C.B.S.E. New Delhi will ensure to take examination of Punjabi in such schools and in addition it is also instructed that in case of non compliance of these instructions, No Objection Certificate will be withdrawn immediately.

3. The school management will comply in letter and spirit the notifications issued under R.T.E. Act, 2009 by the Education Department Punjab Govt. and Rules of R.T.E. Act, 2009 framed for Punjab State.

4. After obtaining the affiliation of C.B.S.E. New Delhi, the school management will be bounded to pay salary and other allowances etc. through account payee cheque to teaching and non teaching staff as applicable to govt. employees. In case of non compliance, the No Objection Certificate will be withdrawn immediately.

5. You and your management will ensure to provide required information and to co-operate for the same as and when any such information is demanded by the District Education Officer or any Senior Officer of Education Department.
